- III- The principal office of this corporation shall be located in Coconino County, Arizona. This corporation may establish such other office or offices, and conduct its affairs, both within and without the State of Arizona, as the Board of Directors may from time to time determine.
 - IV- The purpose of this corporation shall be
- (a) to engage in the transaction of any or all lawful business for which non-profit corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time
