## Neighbors Looking out for Neighbors

It is hard to believe that it was over 30 years ago when a small group of SFE residents got together and decided to form a volunteer fire department in Sherwood Forest Estates. They had tried to contract with Parks/Belmont and Williams, but along with the very long response time and the fact the responders could be held up by a train, these departments became concerned about law suits if they could not control a fire in a more reasonable time so both of them canceled the contracts with little or no notice. It was shortly thereafter that the Parks/Belmont FD went broke and was taken over by the County.

Creating a fire department was a great deal of hard work by many, many men and women, but year after year progress was made. Today we have one of the finest volunteer fire departments in the state. With some of the modern equipment we have it is possible for one person to sit in an air-conditioned cab and spray out a brush fire over a hundred feet away!

Sherwood Forest Estates Fire Department is not just a bunch of people responding to fire calls. It is the center of our neighborhood. It is where we gather for meetings, it is where we gather for parties and it is where fire training takes place.

One of the best parts of SFEFD is that if a situation does arise there is a good chance the responders will be your friends and neighbors. They know the neighborhood and you. Men or women, 18 to 90 there is a place for you in the SFEFD. ## Moonset Pit

Your Sherwood Forest Estates Fire Department encourages you to rake, prune and gather debris from your property and deposit it at Moonset Pit. This is an important step in reducing the risk of wildfire damage to your home.

Moonset Pit will be open on the second and fourth Saturdays of the summer months. On the dates that Moonset Pit is open, fire personnel and community volunteers staff the pit from 9 a.m. until 3 p.m. to ensure access and prevent disposal of unauthorized materials. Only natural, woody debris (such as tree limbs and pine needles) may be deposited at Moonset Pit, located one mile west of Parks, AZ on the north side of old Route 66. Open pit dates for 2015 are as follows:

Moonset Pit Fast Facts:

- YES- un-bagged woody debris, branches, leaves, pine needles
- YES- public access on open dates from 9am to 3pm
- NO- garbage, building materials, treated wood, household items
- NO- bagged items of any kind

## 2014 Public Use Schedule:

The use of the pit is a community service provided to help private citizens create defensible space and improve forest health in their communities. The Kaibab National Forest and the communities of Parks and Sherwood Forest Estates in coordination with the Rural Communities Fuels Management Partnership offer this service.

### DID YOU KNOW? By George Schatz



As we drive through our railroad crossing, we see a sign that reads “CHALENDER.” The sign looks like those used to mark towns. The name tells a wonderful story of a community that existed nearby known as “Chalender.” The name Chalender appeared as early as August, 1882, when it was used synonymously with “Pitman Valley” to designate the stage stop located about nine miles east of Williams. George F. Chalender was the Superintendent of Motive Power of the Atlantic & Pacific Railroad.

The community attained importance as a ranching and lumber town. It thrived from the early 1880s through the turn of the century. When the railroad was being constructed, a saw mill was set up at or very near Chalender. In the 1890’s, several lumber companies established saw mills in Chalender, although their main offices were in Williams.

Chalender enjoyed a post office that was established on May 2, 1883, but was

discontinued on August 27, 1897. The first appointed Postmaster was Harry L. Harris, reportedly “a dealer in ‘liquors’.”

In 1884, Chalender’s population was estimated at 100 people. That year, livestock was listed as a principal product shipped at Chalender. Fourteen livestockmen were listed at Chalender.

In the water short year of 1899, the Saginaw Company hauled water from the Chalender station to its mill in Williams.

After the turn of the last century, Chalender declined, and by 1906, it was described as “a lonesome place.”

So when you read the sign, remember the thriving community that preceded Sherwood Forest.

## How Old Is Too Old?

Here's a fact you may find interesting if not totally amazing. Nationwide, 70 percent of all firefighters are volunteers and a large percentage of those are no longer spring chickens.

Using my own situation as an example, I was 54 years old when I went through the basic Structural Firefighter I & II training which is a good ten years after a career firefighter would have put in for retirement. Who was I trying to impress?

More than 50% of the volunteers on our department's roster are over 60 years old and we are very glad to have them. Typically, a volunteer in his or her "golden years" will bring a built in work ethic to a department, they are aware of the dangers an adrenalin rush can create, are focused and reliable. Mature firefighters are not interested in grandstanding or heroism; they understand the job and perform to the best of their considerable abilities. In our case, it also helps that we have very user friendly equipment and train with age limitations in mind.

What prompted this article is the recent departure of two of our highly valued, gray haired volunteers. They have decided to move to a warmer climate coupled with a more affordable cost of living. The duty performed by the husband and wife team of Bill and Marilyn Gildersleeve in many ways is fairly typical. Marilyn helped in the office, worked as a dispatcher and was active in the Auxiliary while Bill worked on fire trucks and equipment, did building maintenance, assisted in training exercises and was the first guy at the station when the alarm sounded.

What is really remarkable is that Bill has had, for years, a debilitating form of MS. He knew in advance he wouldn't be a frontline firefighter but had a burning desire to help and, fortunately for us, we were able to take full advantage of his many talents. What I will always remember most is the exhilarating feeling I would get as I, and all the others responding to an emergency call, rolled up to the station. Without fail, the bay doors were open, the lights and radios were on and all the engines were running. We only had to grab our gear and select the proper truck for the job. Bill, on many occasions, saved us a great deal of precious time.

The message for those of you who think it might be rewarding to volunteer with an emergency service agency such as a fire department or a local CERT group but feel you couldn't do everything required of a fulltime professional, just think about how valuable Bill and Marilyn were to our department. I wish we had ten more just like them.

## Changes looming in your Fire Department

This just might be the most important newsletter I have ever been asked to write. Our fire district is at a crossroads and I will be asking all of you to get involved in one of the biggest decisions our department has faced since we were established nearly 30 years ago.

Due to our aging population and a lull in the number of new, younger volunteers stepping forward, our fire department is looking into the prospect of merging with the Ponderosa FD.

At the present time there are deeply divided viewpoints on this issue and I am urging everyone to learn as much as you can about the process, the possible ramifications, both good and bad, and then let your opinions be heard.

At this point, our fire board has heard a presentation from Ponderosa's fire chief and has instructed me to move forward with a fact finding plan of action. This will include researching the financial ramifications of such a merger, how the coverage within our district might change and, in general, if such an agreement would be a win/win situation.

In order to accomplish this assignment, I will be forming work groups and committees to research the critical facets of a merger and conduct as many public meetings as may be necessary so that every property owner in the Sherwood Forest Fire District has an opportunity to hear all the facts. We will provide a platform where persons with differing opinions can speak freely and ask the tough questions. If you have an interest in being part of a research or planning group, please contact the office at 635-9837.

Please keep in mind, there are alternative organizational opportunities that could also address the reduction of operating costs and improved responder efficiency. Rather than entering into a permanent merger, one plan is more like an area wide cooperative agreement with a centralized administration office. If we compare this with purchasing a new car, it would be similar to a "trying before buying" scenario. The big advantage to doing business this way is, if it doesn't work as advertised or does not create a working relationship that benefits all parties concerned, it can easily be modified or canceled. That is one big drawback to a merger; once it is in place, there is no going back.

There is no denying, we have some problems that need immediate attention and we are making good progress in resolving them. What we are experiencing is nothing new; we have been here before and successfully worked our way out. Also, our situation is not unique and there are a number of local agencies willing to help us through this rough period.

Throughout it all, we continue to have a top notch fire department. SFEFD has in place a comprehensive, localized training program and possesses firefighting equipment that rivals, or is better than, organizations many times our size. What we do need are more firefighters and it would be beneficial if we rely on people living in our own neighborhood. However, not everyone needs to be a frontline firefighter; we also need more behind the scene workers to keep everything running smooth. Please consider being part of the solution to our current needs.
