# Reports from SFE's Property Owners' Board

# Acting President, Catherine Cook

Freezing temperatures, strong winds, and never ending snowfall, OH MY! What a winter in northern Arizona! Now that most of the snow has melted I am happy to finally be able to say HAPPY SPRING to ALL!!!! And for those of you that live in SFE year round I am sure you may want to shout it!!!

With all the moisture and beautiful flowers we are now enjoying comes the real threat of wildfires when they dry out. Please be diligent and clear away pine needles, dead limbs and trees from your homes (a minimum of 30 feet,) gutters and if possible your property.

There have been several additional weekend rentals sold in SFE this year. If you are living next to or near one, please contact the Fire Dept (#928-635-9837) if you witness outside burning during "NO BURN" days. Also, the sheriff stated last year to not approach individuals breaking rules but to contact them (#928-635-4487.) There is currently a committee comprised of residents and elected officials looking into the ability to dictate new rules to bring stricter guidelines to weekend rentals in our surrounding areas.

It is often stated but bares repeating; Please, *PLEASE* slow down when approaching and passing individual walkers. It only takes a few seconds out of your drive and the walkers do appreciate the consideration to not breathe in the dust. Also, if walking your dogs remember to bring a bag to collect their droppings. This, also, is very much appreciated!

Speaking of dogs, leashes are required for all dogs while walking them in our neighborhood. The county has ordinances for this and persistent barking which disturbs others. If one is reported to the county for either, you could face a fine.

"Sherwood Cares," a collaboration between the POA, Auxiliary and Fire Department, is a group that rallies support for our neighbors that due to unforeseen circumstances find themselves in need. Sherwood Cares is available to assist with meals, transportation to Dr's, small maintenance issues and emotional support. # The Fiber Project Update, Jud Swearingen

Finally, winter is over and work has resumed on the fiber project. Some of the existing underground ducting is being repaired from past damage in Williams. The path to Sherwood Forest Estates has changed to accommodate the build out to Parks and Bellmont. This is taking much longer than any of us ever expected but everyone on the project is pushing forward.

# Snow Stake Project, Jud Swearingen

Do to the heavy snow over this past winter, many of the driveway entrances in Sherwood Forest Estates became unidentifiable not to mention the path of the driveway itself. This would hamper emergency services in time of need. To remedy this problem it was suggested we place snow stakes to identify the driveway entrances and its path. Two orange stakes would identify the driveway entrance, green stakes would show the driveway's path and red stakes would identify hazards such as mailboxes, posts, large rocks, propane tanks or anything else deemed hazardous to first responders and a snowplow. This way when responding to an emergency or giving a resident a way out, a snow plow can clear the driveway safely.

Meetings are open to the public and all concerns and/or input will be taken under advisement. Residents of both Sherwood Forest Estates and Mountain Rose Ranch Estates are welcomed and encouraged to attend.

# Fire Chief Moede's Report

As we move out of winter, I want to thank our members for their commitment to providing excellent preparation and response to our community. We are very lucky to have all of you on the team.

Winter provided us with a number of challenges that included access, driving conditions and patient movement. Through it all we had great internal response from our members and great support from our area partners such as the County plow crew, High Country Fire and Lifeline Ambulance. I am proud of how our members worked to ensure the vehicles were ready and able to respond and to see the effectiveness of our radio repeater system.

Spring will bring a great deal of plant growth from this moisture, which will dry out later in the season. Continued vigilance in ground clearance will be needed by all of us. We are working with the Kaibab Forest to conduct a trees per acre study in order to identify the tree density in our district. My hope is to use the information to convince homeowners of the necessity to thin our trees. I am working on developing outside financial support and contractors to assist homeowners with the thinning process.

The Fire District continues to improve. The Fire Board continues to support us with funding for emergency power at the fire station, funding for improvements to our water trailer project and funding for a newer fast attack vehicle, which just arrived. The Board members have changed recently. We said goodbye to Walter Krushinsky and Sue Hamilton. On behalf of the district, we say thank you to you both for the never-ending support and service to this community. We welcome new board members Roe Irving and Deb Hamby. We look forward to working with you.

We also want to thank the Fire Auxiliary for increasing our equipment inventory with the purchase of a new cut off saw that we will be training with in the future.

As our community grows the fire district continues to strive to provide quality emergency services to the community.

Because of the heavier winter there are several tree limbs down and pine needles are already falling.

# © "Who Woulda Thunk It" ©
